## **ABOUT GATEWAY**

Gateway is a government funded programme through the Tertiary Education Commission (TEC) that has been operating successfully since 2000. The key purpose of Gateway is to assist senior students with career planning and making informed career choices. There is no cost to be involved in this programme and Gateway is open to Year 13 and Year 12 students.

On the Gateway programme, students will gain first-hand experience of a workplace of personal interest as well as working towards achieving credits towards their NCEA qualification. Students learning will be tailored to meet their specific goals and outcomes. Students will attend a workplace during term time, for one day per week for approximately 20 weeks (over Terms 2 & 3) and complete a learning assessment of NZQA approved unit standards.
